A disaster could include any of the previously-mentioned natural phenomena, as well as fire, smoke, flood, even theft. Regardless of what it might be – if you come into work one day and disaster has struck, what will you do if your data has been lost?

When you have data recovery software in place – even in the event of a total loss of your data – it's still not really a total loss. With BDR, your entire building could be completely vaporized – leaving behind only a few ounces of ash, and you could still be back up-and-running on replacement hardware in a relatively short period of time. That's the power of disaster recovery planning: to allow your office to keep functioning – even if there's no more office!



Even a Simple Employee Error Can Be Disastrous to a Business.

Disasters aren't limited to nature, either. Let's look at Simpkins. We all know Simpkins: he's that guy we hired a while back who – through no fault of his own – just can't seem to get things done the right way without some kind of bad luck befalling him. In this particular case, Simpkins was asked to proofread the Standish file: an enormous document the entire office has been collectively working on for the past three annual quarters. Simpkins sees a font change issue, and tries to highlight only the area of the incorrect font, only to accidentally "select all" text within the document. He tries to hit "Command-Z" to undo, but he misses the Command key – and

ends up changing the entire 243-page document into one "z." Panicked, he goes to the title bar and tries to manually click "undo," but – of course – he unintentionally clicks "save." Goodbye 243-page document, 9 months of collective work, and the entire Standish account. Hello "z," fessing up to the cataclysm, and unemployment.

But with BDR, it doesn't have to be this way. Let's assume Simpkins' office wisely chose to use data recovery software in their disaster recovery plan: Simpkins nervously fesses up to the boss, who only shakes his head and chuckles. He then uses his BDR software to retrieve the copy of the Standish file that had just been backed-up the night before. Crisis averted, and Simpkins' job is safe. Well, for now.
